Position Summary

Under direction of the Lead Bridgeman, is responsible for helping with the construction of bridges, culverts, buildings and for basic maintenance of equipment used by the Bridge Crew.

Essential Functions

Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

- Must be able to lift 100 pounds.
- Must be able to climb, stoop, squat, kneel, walk, reach, bend, and stand.
- Must be able to move hands easily and skillfully in order to hammer and saw.
- Must be able to work 40 feet above the ground.
- Must be able to read, write, speak and understand English.
- Must have a Class A Commercial Driver's License

Duties

- Helps with the construction of bridges, culverts, and buildings.
- Operate truck to haul and spread granular surfacing materials.
- Operate truck to spread ice control materials as required to road and bridge surfaces.
- Operate truck or motor patrol to remove snow as required from roads and bridges.
- Transports other materials as needed.
- Cuts trees and brush within ROW.
- Performs basic maintenance to bridges in county, removes rock and other debris from trusses and decks.
- Performs operator level maintenance to assigned equipment and Shed/Shop.
- Maintains required time and equipment records.
- Reports to the Lead Bridgeman any safety hazards or maintenance work needed to roads, bridges or equipment that falls beyond the operator's level of capability.
- Works under direction of another lead worker (Shop, Sign Tech., inspector, or a Foreman) when so assigned.
- Reports all damaged signs or other signing problems to Lead Bridgeman. Makes emergency repairs if possible.
- Interacts with the public and coworkers in a positive manner.
- Performs other duties as assigned by the Lead Bridgeman.

This listing of job duties is intended to provide all parties with basic information as to what is expected of the particular job. This listing cannot be complete in every detail due to the need to accommodate the unexpected and the unusual situations that we all know will occur from time to time in bridge, culvert, and building work. Considerable responsibility rests with the individual employee to see what needs to be done and then to do it or to notify someone who can do it. Likewise, considerable latitude rests with the Lead Bridgeman as to the specific work assignments made in order to meet our total responsibility to the public.

Graduation from high school. Possession of a valid Class A Commercial Driver's License (with air brake endorsement).
