

Board of Supervisors Minutes
March 28, 2022

The Tama County Board of Supervisors met at 9:30 a.m. March 28, 2022. Present: 1st District Supervisor, Larry Vest; 2nd District Supervisor, Bill Faircloth and 3rd District Supervisor, Dan Anderson.

Motion by Vest, seconded by Faircloth to approve the minutes of the March 21st regular meeting. All voted aye. Motion carried

The Board met with Lyle Brehm, Tama County Engineer, to get a road projects report.

At 10:00, the Board held a public hearing for a budget amendment for the 2021-2022 Fiscal Year. The Board reviewed the amendment. There were no public comments. The hearing ended at 10:06. Motion by Faircloth, seconded by Vest to approve the following resolution to amend the 2021-2022 county budget expenditures as published:

RESOLUTION 3-28-2022A

BE IT RESOLVED, that the Tama County Board of Supervisors hereby approves an amendment to the 2021-2022 County Budget expenditures as follows:

- Physical Health & Social Services \$483,602 – Grants/donations received by Public Health not budgeted
- Administration \$599,777 – American Rescue Plan money received, increased occupancy expenses to HR
- Non-program Current \$2,781,015 – Tuck pointing on Courthouse, 911 radio project

Total amendment \$3,864,394. Of this amount \$2,063,602 will be reimbursed by grants and donations. The difference is \$1,800,792 which is covered by bonds purchased for the radio project.
