## Board of Supervisors Minutes October 31, 2022

The Tama County Board of Supervisors met at 8:30 a.m. October 31, 2022. Present: 1st District Supervisor, Larry Vest; 2nd District Supervisor, Bill Faircloth and 3rd District Supervisor, Dan Anderson.

8:30 – 9:00 Employee/Department Head Time

9:00-9:30 Public Comment Time The Pledge of Allegiance was recited.

Present: Supervisors Vest, Faircloth, Anderson. Tama County Auditor Laura Kopsa, several members of the Tama County Against Wind Turbines Coalition. Deputy Sheriff Killian was also present. Supervisor Vest started by saying that there were recent letters to the editor in last week's local newspaper that talk about nepotism in a county office. He stated for the record that that is not true, that the Supervisors appointed someone to that position who had the qualifications and desire to fill the vacant position. This person had also taken out nominations papers for the position and was on the Primary ballot in June. Laura Wilson spoke for Tama County Against Wind Turbines. She talked about the impact turbines have on bats, raptors and other living things. She said there needs to be something in place to protect them. She would like tougher ordinances be put in place. There was discussion about the need for fire suppression equipment on turbines. There was also discussion on the need to update the current Wind Energy Ordinance.

Lyle Brehm, Tama County Engineer, was in earlier to give a road projects report. He asked the Supervisors to approve a contact for work on a bridge on K Avenue in Columbia Township. The low bidder was Peterson Contractors, Inc (PCI), Reinbeck in the amount of \$685,341.17. Motion by Vest, seconded by Faircloth to approve Contract #86-C086-099, Project #BROS-SWAP-C086(99)- - SE-86 for bridgework on K Avenue in Columbia Township and also to direct the Auditor to sign the contract documents upon their return from the contractor. All voted aye. Motion carried.

Motion by Vest, seconded by Faircloth to approve a liquor license for The Thirsty Pig, LLC at Pilgrim Heights Camp, rural Montour. All voted aye. Motion carried.

Amanda Kriegel, Treasurer, has advised the Supervisors of a name change for one of the banks the County has funds in. Great Western Bank, Gladbrook, is now known as First Interstate Bank. Motion by Faircloth, seconded by Vest to approve the following depository resolution and name change:
