8:30 – 9:15 Employee/Department Head Time

9:15 – 9:30 Public Comment on Agenda Items. The Pledge of Allegiance was recited.

Present: Supervisors Hilmer and Anderson. Tama County Auditor Laura Kopsa, Assistant Auditor Karen Rohrs, several members of the public. Deputy Sheriff Schmidt was also present. Richard Arp commented on the Public Health budget. He feels the decision made regarding the Sanitarian issue was a mistake and asked the Supervisors to look more into the statute issue. The Board met with Ben Daleske, Tama County Engineer, to get a road projects report.

Motion by Faircloth, seconded by Hilmer to approve the Double D liquor license. This is a temporary license for use during a rodeo. All voted aye. Motion carried.

The Supervisors opened up discussion of the Treasurer's Semi Annual Report. Amanda Kriegel, Treasurer, was present to answer questions. Motion by Anderson, seconded by Hilmer to approve the Treasurers Semi annual Report. All voted aye. Motion carried.

Motion by Faircloth, seconded by Anderson to approve the Recorder's Quarterly Report. All voted aye. Motion carried.

Motion by Anderson, seconded by Hilmer to approve the Veterans Affairs Quarterly Report. All voted aye. Motion carried.

Vice Chairman Hilmer opened up a discussion about a possible de-appropriation in the Public Health budget. Discussion: The Supervisors were urged to check into the statute of limitations some more. Motion by Anderson, seconded by Faircloth to approve the following resolution to set a public hearing for possible de-appropriation of funds:

NOW THEREFORE BE IT RESOLVED by the Board of Supervisors of Tama County that a public hearing be set for August 21st, 2023 at 10:00 am at the Board of Supervisor's room to possibly decrease the appropriation for the Board of Health in the amount of \$51,000 for FY24.
