

**Board of Supervisors Minutes**  
**June 11, 2024**  
**Special Meeting**

The Tama County Board of Supervisors met at 8:30 a.m. June 17, 2024. Present: 1st District Supervisor, Curt Hilmer; 2nd District Supervisor, Bill Faircloth and 3rd District Supervisor, Dan Anderson. Also, Tama County Auditor Laura Kopsa, Assistant Auditor Karen Rohrs, members of the public.

The Board canvassed the Primary Election results. Motion by Anderson, seconded by Faircloth to approve the following resolution:

**CERTIFICATION (CANVASS) OF TAMA COUNTY ELECTION RESULTS,**  
**PRIMARY ELECTION**

WHEREAS, the PRIMARY ELECTION was held as prescribed by law on June 4, 2024, and WHEREAS, the Board of Supervisors and ex-officio Board of Canvassers have canvassed the vote of said elections in accordance with §50.24 of the *Code of Iowa*, now therefore

BE IT HEREBY RESOLVED that we, the undersigned members of the Board of Supervisors and ex-officio Board of Canvassers of Tama County, Iowa, do hereby certify the following TURNOUT REPORT and RESULTS in the PRIMARY ELECTION, held June 4, 2024, and that no obvious clerical errors were identified during the canvass.

One thousand nine hundred forty (**1,940**) people voted at the polls on election day.

One hundred seventy-six (**176**) absentee ballots were accepted for counting.

One (**1**) provisional ballot was rejected.

A total of two thousand one hundred sixteen (**2,116**) people voted.
