The Tama County 911 Service Board email meeting was called to order via email by 911 Service Board Chair Billie Van Egmond (Dysart) at 5:45 PM on 6/11/2025.

New Business:

Van Egmond sent an email to the 911 Service Board members stating that the 911 Communications Center needs a new recorder. This recorder is a vital piece of equipment to operations as it holds recordings of all phone calls in and out of the Sheriff's Office and radio recordings on all talkgroups on the SARA system used by Tama County. The current recorder is a little over 10 years old and will no longer be able to be serviced. 911 Director Reineke has been in touch with Wahltek, the vendor for the Eventide Recorder, who provided Reineke with a quote for the basics, plus additions and maintenance options. Reineke reviewed the additions and conferred with outside agencies who have the same software/equipment, and chose options based on Tama County's best interest. Tama County is able to take advantage of a 20% discount on the base equipment if the 911 Service Board approves the purchase before early July.

A motion was made by Simcox via email at 6:12 PM on 6/11/2025. Seconded by Bina via email at 9:04 PM on 6/11/2025 to purchase the Eventide recorder with a 4-year maintenance plan at the price of \$66,731.00.

On 6/12/2025, Chair Van Egmond sent an email to all Tama County 911 Service Board members requesting an "aye/nay" vote with a deadline of 5:00 PM on 6/13/2025.
