All parcels remaining unsold will be offered at an adjourned daily tax sale in the office of the Tama County Treasurer, until the next regular annual sale or until all taxes are paid.

Bidder information may be obtained at www.iowatreasurers.org or by contacting the Tama County Treasurer's Office. Bidders are required to complete and submit the necessary documents by 11:59 p.m., Thursday June 15th, 2023.

Any taxpayer affected may avoid tax sale proceedings by making payment of the amount shown to the Tama County Treasurer by 4:30 p.m., Thursday, June 15th, 2023. Property taxes may also be paid on-line at www.iowatreasurers.org.

Any publication errors or irregularities do not affect the legality of the tax sale. After the sale, if a parcel is not redeemed within the period provided in Chapter 447, Code of Iowa, the right to redeem expires and a deed may be issued.
